Public Notice to Revise County Surveyor Fees for Fiscal Year 2020-2021

Effective July 1, 2020

Effective July 1, 2020, the County Surveyor Fees will increase by 3.0% for Fiscal year 2020-2021. The current County Surveyor fee schedule was set according to the County Ordinance 4746, adopted March 16, 2010. This County Ordinance permits fee increases based on the percent change of the Consumer Price Index (CPI), All Urban Consumers, Los Angeles-Anaheim-Riverside. The CPI adjustment of 3.0% is based on the period from January to December 2019.
