The undersigned, to obtain Right of Way Research information on the above noted road pursuant to local ordinances adopted pursuant thereto, does herewith make deposit of the sum of \$\_\_\_\_.00 (see fee schedule) (per Road to be researched) and agrees to pay for the County staff work and expenses reasonably incurred to research, determine and process such application and will receive a transmittal report and list of records used to determine such requested information, if available.

In furtherance of the County policy to recover the full costs and expenses associated with such research and determination, the undersigned agrees to pay and maintain such deposit. In the event that such deposit is determined to be insufficient to cover the future costs anticipated or incurred, the undersigned shall pay to the County Surveyor's Office within thirty days of demand, such increased deposit required for projected costs. Costs shall be assessed at the standard rates allocated for billing purposes by the affected County Departments for the personnel assigned to do the work. The County is authorized to withdraw such costs from any deposit made.

The undersigned may cancel the request for services by written notice to the County Surveyor's Office. The undersigned is liable for the payment of costs incurred until such time as the notice of cancellation is received by the County Surveyor's Office.

Any balance remaining upon completion of the work, or cancellation, shall be returned to the person who made the deposit.

In the event that legal action is necessary to enforce this agreement, the prevailing party shall be entitled to recover all reasonable costs incurred in this matter and reasonable attorney's fees to be awarded as costs in any judgment rendered.

*The undersigned, does hereby acknowledge his/her/their understanding that this information is based on research of available recorded documents, maps and indices. Physical positions on the ground cannot be determined without a field survey to locate record information and monumentation and this application or the results do not in any way indicate physical location of any feature or record. The most current and reliable sources of information available will be used to do this research, but in some cases even after doing the research a clear determination may not be possible and/or no information may be available for the requested road. The information provided is not a legal opinion unless it is stated as such. The County does not provide information on Private Roads.*
